Barriers to sustainability



Lack of Resources

Limited budgets and small staff sizes can make it difficult to allocate resources to sustainability initiatives. Fewer available financial/human resources, often limits ability to implement impactful environmental changes



Limited Influence

SMEs often lack the leverage to demand sustainable practices from suppliers and struggle to access green technologies or funding. Their smaller scale also limits their ability to influence industry standards or government policies, hindering meaningful change.



Measuring Impact

Quantifying environmental and social impact of sustainability efforts is challenging esp. when considering short- and long-term effects. Many benefits, like ecosystem health or community well-being, are intangible or slow to appear, making it hard to measure their full impact. Different industries often need varied assessment methods, complicating the process further.

Isolation or limited Network: Often face difficulties accessing specialised sustainability expertise. limited industry networks or connections. Without established relationships or networks, small businesses may find it challenging to identify opportunities to partner, or to 'join forces' in sharing initiatives



Complexity and Confusion challenges in determining where to start with sustainability, selecting the right methods, and navigating complex, ever-evolving regulations. The task of aligning strategies with specific business goals while adapting to a constantly changing landscape can be overwhelming.



Start Small and Scale Gradually

Embarking on a sustainability journey doesn't require a complete overhaul of your operations all at once. Begin with small, manageable projects that offer immediate benefits and are easy to implement.

Focusing on incremental improvements allows you to build experience and gain insights into what works best for your organization. Celebrate these early wins to demonstrate the value of sustainability initiatives, making it easier to secure support and resources for larger, more ambitious projects.

Prioritise sourcing goods and services from local channels. Handy-person, cleaning service or stationary provider.

Ensure that essential policies such as Health and Safety, Information Security, and Data Privacy are in place and compliant

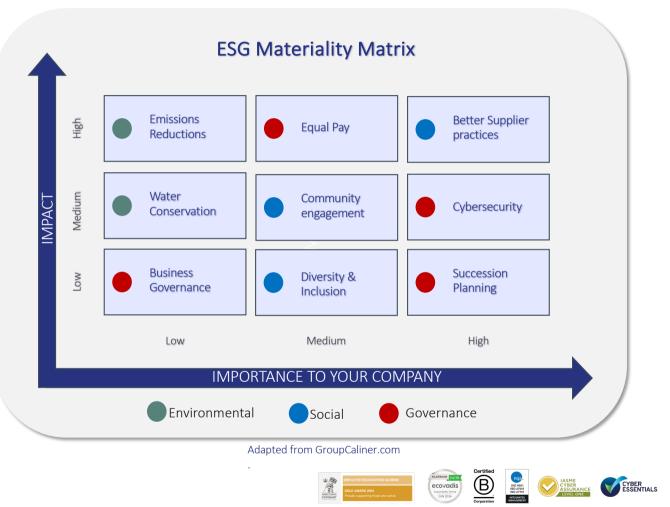
Focus on key Impact Areas

Identify and prioritise key areas where your business can make the most significant impact. For SMEs, focusing on either **"reduction"** (cutting down waste, emissions, or energy use) or **"improvement"** (enhancing efficiency, processes, or sourcing) can yield measurable results in the first year.

By concentrating on one or two areas initially, you can allocate resources more effectively and develop expertise in those specific components of sustainability.

Engage Employees

Host Company-Wide Challenges or Competitions

Organise friendly competitions or challenges centres on reducing or improving a '**focus area'**. For example, host a '*most creative upcycling challenge*' to reduce waste or have a '*Paperless/ Wasteless week*' challenge.

Host a swap shop for unwanted items.

Encourage Employee Led Initiatives

Empower employees to suggest and lead their own sustainability projects. This can range from starting office recycling programs to initiating carpooling or bike-to-work schemes

A sustainability audit is an assessment of a company's environmental, social, and economic practices The goal is to identify areas where the company can improve its impact.	Think about what or how are you are going to report on your progress Formal Reporting: This could include detailed sustainability reports Informal Reporting: This might involve regular updates shared internally with staff or externally with customers	Using the Materiality Matrix method, prioritise focus areas by evaluating their significance, setting a broad vision for what you would like to achieve, and strategically excluding areas with minimal or no influence to concentrate efforts on initiatives that will have the greatest impact	 Use this method: 1. Decide if it is a reduction or improvement goal 2. immediately decide your source of data, how it will be measured and how it will be reported 3. Start small with the vision to scale up over time (it's a marathon) 	Once initial goals are met, expand efforts to more advanced sustainability initiatives. Whether it's investing in renewable energy or supporting social causes, scaling up helps create a more significant impact over time.

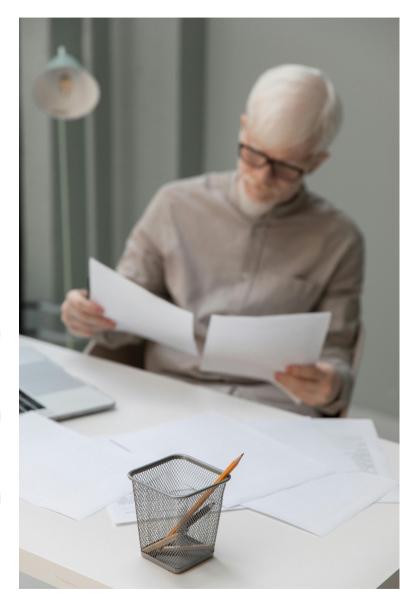

PREPARING YOUR BUSINESS FOR

Office Recycled Art Project

Organise a team activity to create artwork or sculptures using office waste materials such as paper, plastic, and cardboard. Display the finished pieces in the office to raise awareness about recycling and sustainability. Consider auctioning pieces to generate money for charity



Walkathon

Organize a Walkathon or similar event where employees participate in either in a designated area or through a virtual challenge. This promotes health and well-being, fosters team spirit, enhances company culture and raises awareness



Business Incubator

Set up a small-scale incubator program to support startups or small businesses focused on sustainability issues such as governance, environmental or social impact. Provide access to shared resources, mentorship, and networking opportunities at minimal or no cost. This encourages the growth of sustainable businesses, fosters innovation, and provides valuable support to new ventures in the sustainability space.

Urban Beekeeping

Establish an urban bee garden on the office rooftop or nearby green space. Produce honey from the hives and use it as a unique product for the business. Donate the proceeds sales to local causes. Supports local biodiversity and contributes to community welfare through donations.



Rewilding

Undertake a long-term rewilding project by restoring a local area of land to its natural state. This might include reintroducing native plants and animals, creating habitats, and managing the land to support local wildlife. Engage employees and the community in the project.
